he 10<sup>th</sup> Anniversary Kobe University Brussels European Centre Symposium was held

On October 22 the 10th Anniversary Kobe University Brussels European Centre Symposium was held in Brussels, Belgium, under the title "Open Science, Evolving Societies: New Horizons for EU-Japan Research". The symposium was attended by about 140 people including Japanese and EU government officials, researchers, students and business people. Chaired by Professor Kazunari Sakai (Executive Director of KUBEC), the symposium opened with greetings from Professor Hiroshi Takeda (Kobe University President), Professor Dr. Romain Meeusen (Vrije Universiteit Brussel Vice-Rector for Internationalisation), H.E. Mr. Kazuo Kodama (Ambassador of Japan to the EU), and Mr. Jean-Eric Paquet (Director-General, DG Research and Innovation, European Commission). All highlighted the importance of and their hopes for the SPA (Strategic Partnership Agreement).

Parallel sessions were organised under the themes of 1. The EU-Japan SPA and EPA (Economic Partnership Agreement), 2. Food technology, and 3. Cultural heritage. Researchers and policy makers presented the latest results of cutting-edge research and policy initiatives.



The afternoon was devoted to three open interactive workshops under the themes of each session to discuss plans for future joint research projects between EU and Japanese partners.



This symposium illustrated Kobe University's active presence in Brussels, in partnership with the VUB and provided a meaningful opportunity for

academic dialogue between participants from the EU and Japan.

In addition, KUBEC was presented with the Kobe University President's award on October 17 in recognition of its international collaboration efforts in Europe, including the annual Brussels symposium.

#### resident Takeda visited KU Leuven

On October 21, Kobe University President Hiroshi Takeda led a delegation to KU Leuven in Belgium. The delegation comprised Kobe University members Professor Matsuto Ogawa (Executive Vice President in Charge of Research and Information Management), Professor Masahiko Yoshii (Executive Vice President in charge of International Exchange and Evaluation), Professor Hiroko Masumoto (Vice President in charge of International Education and International Collaboration), Professor Ken-ichi Yoshida (Executive Director of the Centre for EU Academic Collaboration) and Professor Kazunari Sakai (Executive Director of KUBEC).

Kobe University and KU Leaven have formed strong ties through student exchange since 2010. KU Leuven also conducts double degree programmes

with Kobe's Graduate School of Economics and Graduate School of Intercultural Studies.

The aim of this visit was to renew the existing agreement in addition to implementing a new student and faculty exchange scheme between each university's Faculty and Graduate School of Law.

At the pre-signing luncheon, both universities discussed how they could continue to work together.

On October 23 Kobe University held an Overseas Advisory Board meeting at KUBEC. The meeting was attended by Board members His Excellency Mr. Herman Van Rompuy (former President of the European Council) and Dr. Hans-Gert Pöttering (former President of European Parliament).



The meeting was chaired by Professor Kazunari Sakai (Executive



Director of KUBEC). Professor Matsuto Ogawa (Executive Vice President in Charge of Research and Information Management) made a presentation on the various research and industry collaboration activities carried out this past academic year. This was followed by Professor Masahiko Yoshii (Executive Vice President in Charge of International Exchange and Evaluation) reporting on the internationalization of education. Kobe University Brussels European Centre Advisor Patrick Vittet-Philippe then reported on the activities of the Brussels office this year.

The two Board members offered their opinions on the importance of strengthening connections and boosting cooperation with European governmental organisations. Their thoughtful evaluations included comparisons with their own institutions.

On October 29, Mr. Pierrick Fillon-Ashida (senior policy officer in charge of Science, Technology and Innovation cooperation with Japan at the European Commission's Directorate-General for Research and Innovation) visited Kobe University to have meetings with Professor Hiroshi Takeda (Kobe University President) and Professor Hisashi Tamaki (Dean of the Graduate School of System Informatics), and to see several of Kobe University's research facilities.

Mr. Fillon-Ashida exchanged opinions about how Japan can increase its participation in European research and innovation funding initiatives such as Horizon 2020 and Horizon Europe with President Takeda.

Professor Tamaki introduced Kobe University's latest "Smart City" research initiatives and discussed Kobe University's low energy technological developments to reduce CO2 emissions.

After the meetings, Mr. Fillon-Ashida visited KUHIMM (Kobe University Human Intestinal Microbiota Model) and the Innovative BioProduction Kobe project.

On October 31 and November 1 a workshop was held at the Kobe University Brussels European Centre (KUBEC) on the theme of "The rule of Law, Democracy and Constitutionalism: Dialogue between Japan and Europe".

Constitutionalism in Japan and Europe, including the principles of the rule of law and democracy, has begun to waver in recent years. The proposed amendment of the Constitution in Japan and a surge of populism due to the refugee and migrant crisis in Europe are typical examples.

The workshop was organised by Professor Noriyuki Inoue (Graduate School of Law) with the aim of reconsidering the normative contents of the fundamental principles of Constitutionalismincluding the rule of law, democracy and the guarantee of basic human rights.

Professor Masahiko Yoshii (Executive Vice President in charge of International Exchange and Evaluation), in addition to researchers from other universities in Japan, Germany, Austria, Poland and Italy attended this workshop.






